CREDIT TERMS: (check one)

- C.O.D. Payment made at the time of delivery.
- CHARGE - Payment is due within 10 days of the delivery date.
- BUDGET - 10 equal monthly payments. The first payment is due on the 1st day of June and monthly thereafter.

DELIVERY: (check one)

- AUTOMATIC DELIVERY - Your oil consumption is computed by degree days, and your next delivery is automatically made.
- WILL CALL - You must call as you need oil. The minimum delivery is 100 gallons. 24 hour notice is suggested.

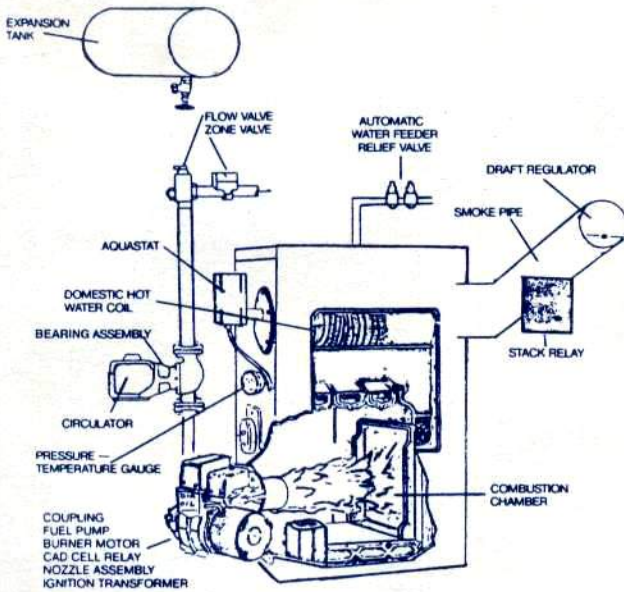
CANCELLATION:

Delivery of oil will continue from year to year unless 30 day written notice of cancellation is received by COCHRAN OIL COMPANY; or if credit terms have not been met.

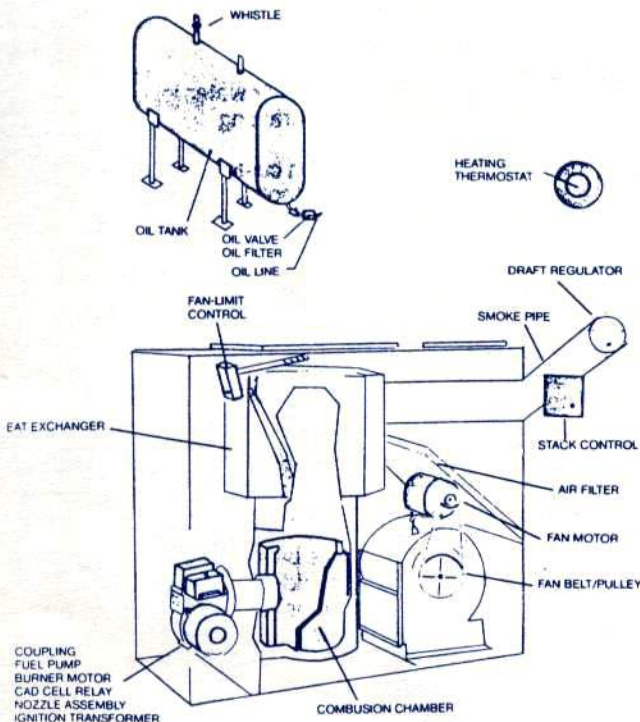

TIME AND MATERIAL

Service is available to all COCHRAN OIL CO. customers on a time and material basis. Contract customers will be taken care of first.

Air conditioning and Plumbing Service is available for central air conditioning systems and plumbing.

CONDITIONS

To keep contract in force, customer (owner and tenant) must pay for all fuel oil, parts, labor, or other chargeable items when due; must be purchasing their full requirements of heating oil from COCHRAN OIL COMPANY, and not permit anyone other than a company authorized service technician to service the burner and equipment. No refunds or credits will be given on premature termination. If any other company or individual works on the covered unit the contract becomes null and void and will be serviced on a time and material basis.

ASSIGNMENT:

The customer is hereby authorized to assign this agreement to a future purchaser of the property who agrees to assume the obligations and conditions in the agreement in writing and becomes a credit-approved COCHRAN OIL CO. customer. This plan is understood to have no refund value from the company.

This agreement does not include:

1. Labor or parts needed as a result of an act of God, war or other abnormal occurrences or situations such as: fire, flood, water damage, lightning, freezing, power failure; fuel run-outs when account is in arrears, or not on automatic delivery; blown fuses, circuit breaker or emergency switch in the "off" position; improper thermostat setting; frozen oil lines, dirty air filters; abnormal water conditions; failure to maintain proper water boiler level; opening of feed valves; purging air from baseboard/radiators; blocked or faulty chimneys; any other call that does not relate to parts or service identified as covered such as:

1a. Labor or parts on heat pumps, air conditioning service, electronic air cleaners, stack dampers, hot water storage tanks, or other add-on equipment not considered standard to operate heating unit, or

1b. Any plumbing or electrical wiring that is not part of the covered heating system; any piping, equipment, or wiring which is not fully accessible.

2. Any guarantee that the existing heating system has the ability to supply the amount of heat and hot water that may be desired.

We will not be liable for damages resulting from heat failure in a vacant or unoccupied home, whether such damage results from burner failure or lack of fuel, as vacant property should be prudently inspected daily by the property owner or owner's agent.

Acceptance does not obligate the company for secondary damages, loss caused by tank or oil line leakage, malfunction, or failure to render service to provide parts due to situations beyond our control.
